## **Artificial Insemination**

### ***Rules for the use of Fresh/Chilled/Frozen Semen***

The following Rules as set down by the Council of The Highland Pony Society must be strictly adhered to for Artificial Insemination by licensed Highland pony stallions. Failure to comply with these Rules will result in the offspring being ineligible for registration in the full Stud Book. Members are advised to contact their veterinary surgeon with regard to complying with the 'Guide to the Use of Artificial Insemination in Horse Breeding' which must be followed. #### **Rules:**

- 1 Semen may only be collected from licensed, DNA tested stallions.
2. Insemination of mares must be carried out by a veterinary surgeon or approved AI technician who MUST complete and sign two copies of the Certificate of Insemination clearly marked showing the date of the insemination. One copy should be given to the mare owner for submission to the Society with the foal registration application and one copy given to the semen owner for retention.

#### **Other Information:**

- 1 DNA testing kits are available from the Society and must be paid for (£50.00) prior to being sent out.
- 2 An animal needs to be DNA tested only once in their lifetime.
- 3 The cost of registration of a foal conceived by AI is the same as a foal from a natural covering.
- 4 Foals conceived by AI will not normally have to be DNA tested.
- 5 All veterinary expenses and stud expenses incurred are between the mare owner and the stallion owner.
